



Cecil College to Delaware Valley University

Dual Admissions Agreement:

If you complete an Associate of Arts (A.A.), Associate of Science (A.S.), Associate of Applied Science (A.A.S.) and Associate of Arts in Teaching (A.A.T.) degree at Cecil College you are guaranteed admissions at DelVal University. Students must still meet all admission requirements for specific bachelor degree majors.

Core-to-Core Agreement:

DelVal agrees to accept the General Education Core embedded in the Cecil College Associate of Arts (A.A.), Associate of Science (A.S.), and Associate of Arts in Teaching (A.A.T.) degree programs degrees as meeting all the requirements of its undergraduate General Education requirements.

This core-to-core agreement applies to all CC A.A., A.S., and A.A.T. graduates, and is not limited to students who participate in the Program-to-Program agreement. Students who change their program of study may be required to take appropriate pre-requisite courses either at DelVal or at CC.

Program-to-Program Agreement:

The Program-to-Program agreement facilitates the transfer of Cecil College students who have completed CC associate degree programs identified in this agreement into the corresponding degree programs at Delval. Identified programs are listed in **Appendix I**. Subject to the terms of this agreement, a student who completes the Associate degree at CC will be conditionally admitted* into a related Bachelor's degree program at Delval and assured third year (junior) status.

*Full admission will be granted after the submission of all required documents including, but not limited to, completed application, transcripts and portfolio (if required).

Terms and Conditions:

- Students must complete the Delval Dual Admission Intent Form before completing 30 college-level credits. This includes credits earned from previous institutions.
- A minimum grade of "C-" is required to transfer a course to Delval. All courses must be college-level.
- •The minimum cumulative GPA required for admission to DelVal under this agreement is 2.0. However, each degree program may have different requirements.
- Delval will accept a maximum of 78 credits in transfer from all prior colleges and universities.
- DelVal has a 48 credit residency requirement, 15 of these 48 credits must be in the major.
- •The student must meet all applicable DelVal requirements and deadlines pertaining to application for admission and payment of tuition and fees.
- •Students transferring under this agreement will be eligible for financial aid and housing on the same basis as native Delval students. Housing assignments for Early College Academy students will be made using the same criteria as freshman students.
- Delval will waive the application fee for students who apply to Delval pursuant to this agreement.
- DelVal agrees to award academic scholarships to all qualified students admitted to DelVal pursuant to this Agreement as stipulated in **Appendix II**.
- •Students who successfully complete the A.A., A.S., A.A.S. or A.A.T. degree at CC and the courses outlined on **Appendix I** will be admitted to DelVal, will enter with third year (junior) status and are assured transfer credit as indicated.
- Courses in degree programs not included in **Appendix I** will be evaluated by DelVal on a course-by-course basis.
- •Students transferring to a related Delval Bachelor's degree program from an eligible CC Associate degree program will transfer their entire Associate degree and may transfer additional applicable credits, up to a total of 78 credits. This includes credits from all prior colleges and universities.
- •This Core-to-Core Agreement applies to all CC A.A., A.S., and A.A.T. graduates, and is not limited to students who participate in the Program-to-Program Agreement.
- •Students who transfer under the terms of this agreement must apply for admission to DelVal within one year of CC graduation.
- Cecil College students who do not complete an eligible associate degree from the community college will not be granted automatic admission to Delval and must apply for admission under the regular transfer admissions process.
- •Students who change their program of study may be required to take appropriate pre-requisite courses either at DelVal or at CC.

Appendix I

Eligible Programs for the Program-to-Program Transfer Admission Agreement

Only the Cecil College and corresponding Delval degree programs identified below are governed by the terms of the Guaranteed Transfer Articulation Agreement. Cecil College students interested in matriculating into a Delval bachelor's degree program under the terms of this agreement are strongly urged to contact the applicable DelVal transfer admissions officer early in their enrollment at CC for counseling and advisement. Official program-to-program transfer guides will be developed for each degree program as CC students in those majors go through the Delval admissions and transfer credit evaluation process.

Appendix II

Guaranteed Transfer Articulation Agreement Scholarships

Effective September 2017

Full-time Student Scholarships

- Full-time students (enrolled in 12 or more credits a semester) with a 3.5 -4.0 final CC GPA will receive a \$21,000 scholarship per year.
- Full-time students (enrolled in 12 or more credits a semester) with a 3.0 3.49 final CC GPA will receive a minimum of \$19,000 scholarship per year.
- Full-time students (enrolled in 12 or more credits a semester) with a 2.5 2.99 final CC GPA will receive a minimum of \$17,000 scholarship per year.
- Full-time students (enrolled in 12 or more credits a semester) with a 2.0- 2.49 final CC GPA will receive a minimum of \$15,000 scholarship per year.
- Full-time students (enrolled in 12 or more credits a semester) who are members of Phi Theta Kappa will receive a 1,000 PTK scholarship per year.

Part-time Student Scholarships

- Part-time students (enrolled in 6 to 11 credits a semester) with a final CC GPA of 3.0 or higher will receive a minimum of a \$1,500 scholarship per semester for the fall, spring and summer terms.
- Part-time students (enrolled in 6 to 11 credits a semester) with a final CC GPA of 2.0 to 2.99 will
 receive a minimum of a \$1,000 scholarship per semester for the fall, spring and summer terms.
- Part-time students (enrolled in 6 or more credits and less than 12 credits) who are members of Phi Theta Kappa will receive a \$250 PTK scholarship per semester for the fall, spring and summer terms.

Additional Scholarship Information

- All scholarships may be renewed each year contingent upon the student remaining in good academic standing at DelVal.
- CC students who initially enroll at Delval as part-time students and wish to change to full-time students will be awarded institutional scholarships based on their current cumulative DelVal GPA.
- CC students who initially enroll at Delval as full-time students and wish to change to part-time students will be awarded institutional scholarships based on their current cumulative DelVal GPA.
