Admissions

- Courses that fulfill the program requirements are only eligible for transfer if the students have earned a grade of "C" or better.
- Students must have a 2.5 cumulative GPA at the time of application
- Students intending to transfer should complete the admissions application for Stevenson University once they complete 45 credits of the Associate Degree program.
- Students who have completed an associate degree at a Maryland community college are guaranteed admissions to Stevenson.
- Students should contact the Financial Aid Office at Stevenson University as soon as possible in regard to college deadlines for Financial Aid.
- Stevenson participates in general education block transfer. Students entering Stevenson with an A.A.,
 A.S., or A.A.T. degree from a Maryland community college will have met all of Stevenson's general
 education requirements, with the exception of a second composition course if not already taken. Not all
 programs are eligible for block transfer.
- Stevenson University will accept up to 70 credits from 2-year institutions. Up to 90 credits can be applied
 to degree requirements from a combination of 2-year institutions, 4-year institutions, and non-direct
 classroom instruction (including CLEP, AP, and other nationally recognized standardized examination
